- Each American depositary share ("ADS") represents 45 Class A ordinary shares, par value US \$0.001 per share, of the Issuer. The number of ADSs reported herein includes 12,375,000 time-based restricted stock units (the "RSUs"), which will vest in equal monthly installments over an 15-month period, beginning March 14, 2023. Each RSU represents a contingent right to receive one Class A ordinary share. Subject to tax withholding, the Issuer will deliver one ADS to the Reporting Person for every 45 vested RSUs.
- The option shares are fully vested and exercisable as of March 22, 2018.
